Reevaluates the treatment plan according to the client's need over time. Partners with the student and collaborates with other relevant parties in the service of developing support plans for the student. Communicates with staff, parents, families, or designated emergency contacts regarding emergencies, including hospitalizations and other crises, to help facilitate student success on campus, or transition back to campus if possible when issues are appropriately resolved. Consults regularly with the various departments on campus regarding services, access, and care. Builds and maintains collaborative relationships with SHSU campus agencies and community providers to include mental health, physical health, social services and community support programs. Helps develop a database of community resources. Provides direct clinical services to Counseling Center clients as appropriate.Serves as the referral coordinator for students in need of off-campus resources. Performs other related duties as assigned.
